

**MyPAC Political Contribution and Mylan Inc. Trade Association Memberships Report: 10-01-2017 to 03-31-2018**

**About this report: This report notes the political contributions of MyPAC to political candidates and political action committees as well as donations and dues paid by Mylan Inc. to certain trade associations.**

*From October 1, 2017 through March 31, 2018, MyPAC contributed \$33,700 to candidates and political action committees ("PACs") in 9 States.
