

Return Goods Policy for Indirect Accounts

For purposes of this policy only, as used herein, the term Mylan Institutional shall include (a) Mylan Institutional Inc., (b) Mylan Institutional LLC, (c) UDL Laboratories, Inc. (n/k/a Mylan Institutional Inc.), (d) Bioniche Pharma USA LLC (n/k/a Mylan Institutional LLC) and (e) Mylan Bertek Pharmaceuticals Inc. (collectively, "Mylan Institutional").

- A. **PRIOR AUTHORIZATION IS NOT REQUIRED FOR RETURNS. This policy applies to outdated product only. The returned goods agent may be contacted via phone at 800-950-5479 or by email at GPScustomerservice@gencoatc.com.**
- B. **RETURNABLE ITEMS:**
1. OUTDATED FULL UNIT CARTONS NOT MORE THAN TWELVE (12) MONTHS PAST THEIR EXPIRATION DATE ARE RETURNABLE.
 2. Mylan Institutional products must be in the original sealed Unit Cartons to be returnable. No payment will be issued for products repacked or in anything other than original Mylan Institutional container.
- C. **NON-RETURNABLE ITEMS: All product not specifically identified in Paragraph B above, are non-returnable items. The following list of non-returnable items is for example only, and shall not be construed as an all-inclusive list:**
1. In-date Products
 2. Product more than twelve (12) months past expiration date.
 3. Products that require refrigeration.
 4. Products designated as CII product, unless mandated by state law.
 5. Partial quantities unless mandated by state law.
 6. Products affixed with prescription labels.
 7. Product which has deteriorated because of inherent characteristics, a result of improper storage, or product involved in sacrifice, or bankruptcy sales.
 8. Products adulterated, damaged by fire, smoke, water, or other influences beyond Mylan Institutional control.
 9. Product purchased by a wholesaler/distributor that was not purchased directly from Mylan Institutional.
- D. **THE DEA FORM 41:**
1. Registrant's Inventory Drugs Surrendered will be processed by GENCO Pharmaceutical Services located in Wisconsin. The DEA Form 41 must include lot number and expiration date.
- E. **TRANSPORTATION CHARGES:**

- F. **TERMS:**
1. A check will be issued for all eligible products within four (4) to six (6) weeks after receipt of product. Mylan Institutional reserves the right to value such goods at a current market value. Processing and disposal fees attributed to any processors other than Genco Pharmaceutical Services will not be reimbursed by Mylan Institutional.
- G. **COMPANY DISCLAIMER:**
1. Mylan Institutional, in its sole discretion, reserves the right to destroy product as having no value when deemed unfit for sale.
