

MyPAC Political Contribution and Mylan Inc. Trade Association Memberships Report: 04-01-2019 to 09-30-2019

About this report: This report notes the political contributions of MyPAC to political candidates and political action committees as well as donations and dues paid by Mylan Inc. to certain trade associations.

From April 4, 2019 through September 30, 2019, MyPAC contributed \$160,000 to candidates and political action committees ("PACs") in 21 states. MyPAC is the political action committee formed by Mylan employees and funded by the contributions of employees. Mylan Inc. did not make any contributions to candidates or PACs during this time period.
